Girl and Specially-abled students from the batch of 2019-20 (if any), who are promoted to the next respective higher year and already availing any of this scholarships from AY 2019-20, are eligible for these scholarships as Renewal cases. - 3. This Income Certificate shall be used only for educational purpose (for getting scholarship, merit award etc). Income Certificate for scholarship purpose may be issued within 3(three) days from the date of receipt of application.
